## TIGER CARE BENEFITS

You never know what's coming down the line. It could be an illness or injury that lands you in the hospital or an accident that sends you to the ER or urgent care.

When filing a claim, it is necessary to submit the Explanation of Benefits provided by Your Primary Medical Policy.

TigerCare will pay deductibles or coinsurance as outlined below for which You are responsible under Your Primary Medical Policy, up to the Maximum Benefit each Plan Year.

### Group Limited Indemnity Benefits and Definitions

#### Benefit amount/maximum

All amounts are payable per insured per day, up to a maximum number of days per insured per year

#### Inpatient hospitalization benefits

##### Hospital Confinement

For treatment in a hospital, due to sickness or injury for 23 or more continuous hours (i.e., not less than a day) Note: Maternity benefit is payable as any other illness

**\$300 per day**  
**5 days per year**

##### Hospital Admission

Lump sum benefit for a hospital admission, due to sickness or injury

**\$1,750 per day**  
**1 day per year**

##### Hospital Intensive Care Unit

For intensive and comprehensive care, when confined in an area equipped with lifesaving equipment (ICU)

**\$500 per day**  
**5 days per year**

#### Surgery benefits

##### Outpatient Major Surgery

For outpatient major surgery in hospital or freestanding surgery center, due to sickness or injury

**\$1,250 per day**  
**1 day per year**

##### Outpatient Minor Surgery

For minor outpatient surgery in hospital or freestanding surgery center, due to sickness or injury Note: Must be eligible CPT code

**\$300 per day**  
**1 day per year**

#### Physician's office/urgent care benefits

##### Physician's Office/Urgent Care

For services rendered by a physician at physician's office or urgent care facility

**\$30 per day**  
**3 days per year**

#### Accident rider

##### Accident Rider

For treatment of an accident within 72 hours of incurred date

**\$300 in Urgent Care**  
**\$750 in ER, and**  
**\$1,000 in hospital per day**  
**1 day per year**
